Welcome Package

The Board has prepared an information package for new owners and residents to welcome them to Fairlington Glen and provide them with immediately useful information. The welcome package covers communication mechanisms, useful contacts, activities calendar, trash and recycling, maintenance and repair, insurance, water usage, and caring for our sewer system. It was distributed to the homes of new 2007 owners last month. Members of the Court Representatives Group (CRG) who attended its January meeting each received two copies for distribution to new owners and renters in 2008. By-Laws Revision

Our legal firm, **Rees Broome**, has prepared a revision of the Glen's bylaws to bring the Glen into the 21st century. Our bylaws have not been changed for over 30 years and do not take advantage of the many changes that have occurred in the Condominium Act of Virginia or the technological changes that have occurred in the world. Computer communication via e-mail did not exist when our bylaws were written n 1973, as odd as that may seem to many of you, who can't imagine a world without e-mail (can any of us now?). The charge for late assessments contained in the bylaws is \$3.00 (that is not a typo). We also now have over 30 years of experience interpreting and applying the Master Deed and bylaw provisions in allocation of maintenance and repair responsibilities between the Council and its co-owners, which the Board summarized in last August's memo to co-owners. The mutual obligations of the Council and its co-owners are included in the revised bylaws.

At its February meeting the Board reviewed the proposed bylaws revisions. President **Bob Patrician** has asked the CRG, as well as a group composed primarily of former Board members who have worked with the existing bylaws, to meet with our legal advisors at the **Thursday, March 6**, Board meeting to discuss the proposed revisions. **Peter Philbin**, our lead lawyer, will explain the rationale for the proposed changes and lead the discussion. At a later date, the Board will present bylaw revisions to the community at a Community Forum to seek your support. Given the 75 percent vote needed for approval, we want you all to understand the benefits of the proposed changes. We look forward to engaging the entire community in this effort.

Seeking Space

The Glen needs office space for **Nelson** and **Maria** during pool complex renovation from approximately September 2008 through February 2009. We seek basement space (6:30 am to 3:00 pm Monday to Friday) that would provide an office with computer and phone access (we would bring our own) and bathroom facilities.
