### Thoughts From The Board President

Fairlington Glen's Annual Meeting will be Wednesday, November 4, 2015, at 7:00pm at the Fairlington Community Center, 3308 S. Stafford Street. All co-owners are encouraged to attend in order to discuss and approve a budget for Fiscal Year 2016 and to elect two directors to the Board. In addition, the minutes from last year's meeting will be up for approval.

A quorum consisting of more than 25% of ownership interests is necessary to conduct business. All co-owners

are strongly urged to attend in person, to appoint proxy holders to represent their interests at the meeting, or to participate by electronic voting. Voting information is contained in the Annual Meeting Packet that was mailed to all co-owners last month.

Kathryn Frazier is the new rep for Court 13, and we thank her for volunteering.



### LANDSCAPE COMMITTEE NEWS

Happy fall from your newly formed Landscape Committee of seven residents! Our mission is to help beautify and maintain our beautiful grounds, keep you informed about ongoing projects, and to ask for your help in making the Glen a desirable place to live. Here is some current information on upcoming events and issues:

**Turf Aeration & Reseeding** - Recently, our landscaping contractor, Environmental Enhancements (EE), aerated and reseeded our turf. Unfortunately, it rained the day before causing a somewhat muddy event. Then several days of rains came (good), but it washed away some of the seed (bad). If you desire, it's fine to get a small bag of seed, or split a bag with your neighbor, and throw out more seed in the bare areas where grass is not coming up.

**Spring Planting Is NOW** - This is the best time of year to do most yard work, including planting shrubs, perennials, bulbs, and of course grass seed. The cool weather is good for establishing strong root systems for spring.

**Red Reflector Club** - Look for more information about red reflectors for 2016 coming in February.

### BRING YOUR PHOTO ID TO VOTE

As of July 1, 2014, the new law in Virginia requires Virginia voters to show an acceptable form of photo identification at the polls before they'll be able to cast their ballot.

Acceptable forms of photo ID in Virginia include:

- 1. A Virginia driver's license or DMV ID card
- 2. Any government-issued photo ID (U.S., Virginia, or Virginia local government)
- 3. A U.S. Passport, Naturalization Certificate, or military ID
- 4. An employee ID card with a photograph
- 5. A student ID card with a photograph from any Virginia college or university
- 6. An Arlington Senior ID with a photograph issued by the Sheriff's Office

Please note that ID's with expiration dates must be current OR not expired more than 12 months before the election.

It's out with the old and in with the new old way at the polls. Arlington County voters will be marking paper ballots instead of using the previous touchscreen electronic voting system, which was aging and decertified earlier this year by the Virginia State Board of Elections. State law now mandates that all new voting systems purchased in Virginia be paper based.

So when you head to the polls on Tuesday, November 3 you will mark a paper ballot and then insert that ballot into a scanner which will count your ballot and make a digital image of the ballot as a back up.

With the new system come some advantages, such as the ability to have more voters voting concurrently and the creation of an audit trail.

The new, easy-to-use system debuted in Arlington this past summer during the June Democratic primary. For more information before going to the polls, please visit <a href="www.vote.arlingtonva.us">www.vote.arlingtonva.us</a> or call 703-228-3456.

# THE GLEN 10 10 Q's & A's with Audrey Mullen

Maybe you've seen their faces, but do you know their stories? Get to know your neighbors in the Glen each month through this feature we call the Glen 10.

- 1. Where are you originally from? What brought you to Arlington? "Monmouth Beach, NJ. I moved here right after college to start my first job."
- 2. What year did you buy in the Glen? What model do you own in Court 2? "1994 a Barcroft."
- 3. Where did you go to school, and what did you study? "Sweet Briar College where I majored in English."

- 4. You must be relieved that Sweet Briar did not close this summer as originally planned. What did you think when you first heard the news about the plans to close the college? "It was like a kick in the stomach. Then I was furious and wanted to help turn it around."
- 5. Certainly one's alma mater means a lot to everyone. How proud are you that Sweet Briar remains open as an outstanding place for women to study? "I am very proud of the women who organized online, formed various working groups, agreed on a legal strategy, raised a lot of money, organized a media campaign and saved our school...while also working full time and/or raising their families. I was happy to volunteer on the fundraising team. Pro tip: never tell a group of women that something is impossible or that they need to quietly accept the bad news. It tends to get them riled up."
- **6.** You work in public relations. Where do you work and what kinds of clients do you work with? "I do PR for non-profit groups and issue campaigns. Some of the work is business oriented, some is related to education. I also organize book and film promotions."
- 7. Working from home, whether full time or just occasionally, takes a degree of self-discipline. What are the advantages and disadvantages to working from home? "I have an office in DC. If I try to work from home in the morning, I find myself snacking and tidying things while I'm on the phone."

8. You seem to have a passion for rescue dogs. How did you first get involved? And do you aim to match the dogs to new owners or do you keep them yourself? "My mother helped build an animal shelter in New Jersey. I grew up in a home full of animals and just can't imagine life without pets. Breed-specific rescue groups have really taken off since they were able to organize online. The first rescue group I volunteered for Basset Rescue of the Old Dominion. I love all dogs, but have gravitated towards smaller dogs (Cavalier King Charles Spaniels) in recent years. I talk to potential adopters about their lifestyles: how often they exercise, whether they will get up early on a cold morning to walk a dog, how they will housebreak a puppy, if they have a problem with allowing animals on the furniture and whether they understand the expenses associated with pets. Sadly, a lot of people just don't think it through and that's why they give up their dogs. Yes, I have been a 'foster failure' several times, but I have a thing for old dogs and sad stories. I would like to think that the last few years of their lives offset the pain they experienced early on."



- **9. What are some of your favorite aspects of life in the Glen?** "I love walking around and seeing all the strollers and carriages. It seems like everyone has a dog or a toddler. Once you have a child or a dog, you get to know your neighbors."
- **10.** Lastly, when you're not working what are some of the things you enjoy doing most? "Cooking for friends, film festivals (particularly documentary films), learning about new wines and following political campaigns."

# CO-OWNERS' RESPONSIBILITIES INCLUDE PIPES WITHIN UNITS



Co-owners are responsible for all pipes within their units including those that pass through their units but serve other units. Burst pipes are the co-owner's responsibility, so be sure to take precautions.

During the winter months, residents should shut off water to outside faucets, remove hoses, and open outside spigots. Also, thermostats should be set no lower than 55 degrees to protect indoor pipes.

In all but the B Building units, the front water spigot turnoff is typically located above the water heater and the back water spigot turnoff is under the kitchen sink. In B Buildings, the lower unit apartments' front and back water spigot turnoffs are in the laundry room above the water heater.

Please take the time now to find and label your water spigot turnoffs so you'll be prepared as colder weather approaches. And again, make plans to disconnect your hoses and bring them indoors for the winter.

In addition, you should also know where your unit's main water supply valve is located so you can quickly shut off the water to your unit if a pipe breaks.

If pipes are exposed to cold air, wrap them with insulation. The most vulnerable pipes are along exterior walls and those that bring water into a home or building at its foundation.

During periods of extreme below freezing temperatures outside, keep pipes inside in kitchen cabinets and bathroom vanities warm by opening the doors to the cabinets and vanities to let heat in. Also, keep an upper-floor cold water tap open just enough for a drip to keep water moving through the pipes. Be sure to keep an eye on the tap.

When in doubt, always call a licensed, registered plumber for expert advice and assistance.

### NO FLUSH / NO DRAIN!

With the holiday season upon us, you may have company coming to visit. Or, perhaps you are new this year to the Glen. In either case, it's always good to remind you about our delicate pipes and what not to put down our Glen drains and toilets.

Sanitary sewer lines in the Glen must be treated with care. Only human waste and toilet tissue should be disposed of in toilets. Most garbage should go in the trash, not down the disposal. "Less is more" is a good motto for Fairlington sewers. These items should NEVER be disposed of in our sewer system:

Adult and baby wipes (even if labeled as flushable)

Disposable diapers

Large wads of toilet paper

**Tampons** 

**Condoms** 

Pet waste or litter

Tissues, napkins, or paper towels

Dental floss

Cigarette butts

**Medicines and pills** 

Celery, onions, or potato peels

Pulpy fruits or fruit seeds

Grease

Pasta or rice

Egg shells

Coffee grounds

Corn husks

Shrimp shells

**Bones** 

Caulk

Paint

Please be sure your guests, babysitters, and contractors are aware of this guidance. And don't be afraid to tell new neighbors about this practice. All of the waste noted above belongs in your daily trash and NOT in our sewer system. In fact, you may want to print this page and the following page to use for reference. Thank you!

Sewer backups can be expensive and a nightmare. We must care for our aging sewer system, which was built in the 1940's.

Help keep condo fees and rents down by being careful about what you put in your toilets.

### **BULK TRASH REMINDERS**

Large trash or bulk trash is collected once per month on the first Saturday of the month by our contractor, Capitol Services. Large items should be placed before 9:00am on the day of pick up at the entrance to your court by the court sign. Please do not place items at the base of our large trees and their roots.



Bulk trash is that which is generated through the normal occupancy of the unit by the resident as a result of normal maintenance. Please remember that removal of renovation/construction debris is the responsibility of the co-owner/resident and this debris may not be left out for Capitol Services to collect.

Under our trash contract, the following materials are not allowed: dead animals, oil, paint, batteries, construction materials, manure, tree stumps, dirt, stones, rocks, concrete, bricks, poisons, dangerous acids, caustics, explosives, and other dangerous materials.

For disposal of hazardous wastes such as paints, motor oil, household chemicals, and other toxics, please contact the Arlington County Water Pollution Control Plant at 703 -228-6820.

### BEWARE OF PORCH PIRACY



As we head into the holiday season, more and more residents will be shopping online. And of course that means more and more of us will be receiving packages from the US Postal Service (USPS), United Parcel Service (UPS), and others. Before placing your orders, please be aware of porch pirates and take steps to ensure that your deliveries are not stolen.

According to a recent CBS News report, porch piracy is happening across the country. And we know that Fairlington is

no exception because there were reports of package thefts during the holidays last year. Porch pirates simply steal boxes and other delivery items right from front stoops and doors, often during daylight hours while residents are at work or away from home.

The National Retail Federation says consumers will do half of their holiday shopping online this year, which means USPS and UPS trucks will be constant visitors to our courts. In order to help prevent package thefts, residents should make arrangements with their friends and neighbors in the court to let them know a package may be coming while they're at work or out of town. Have that neighbor grab any deliveries you may get and pick them up when you get home.
